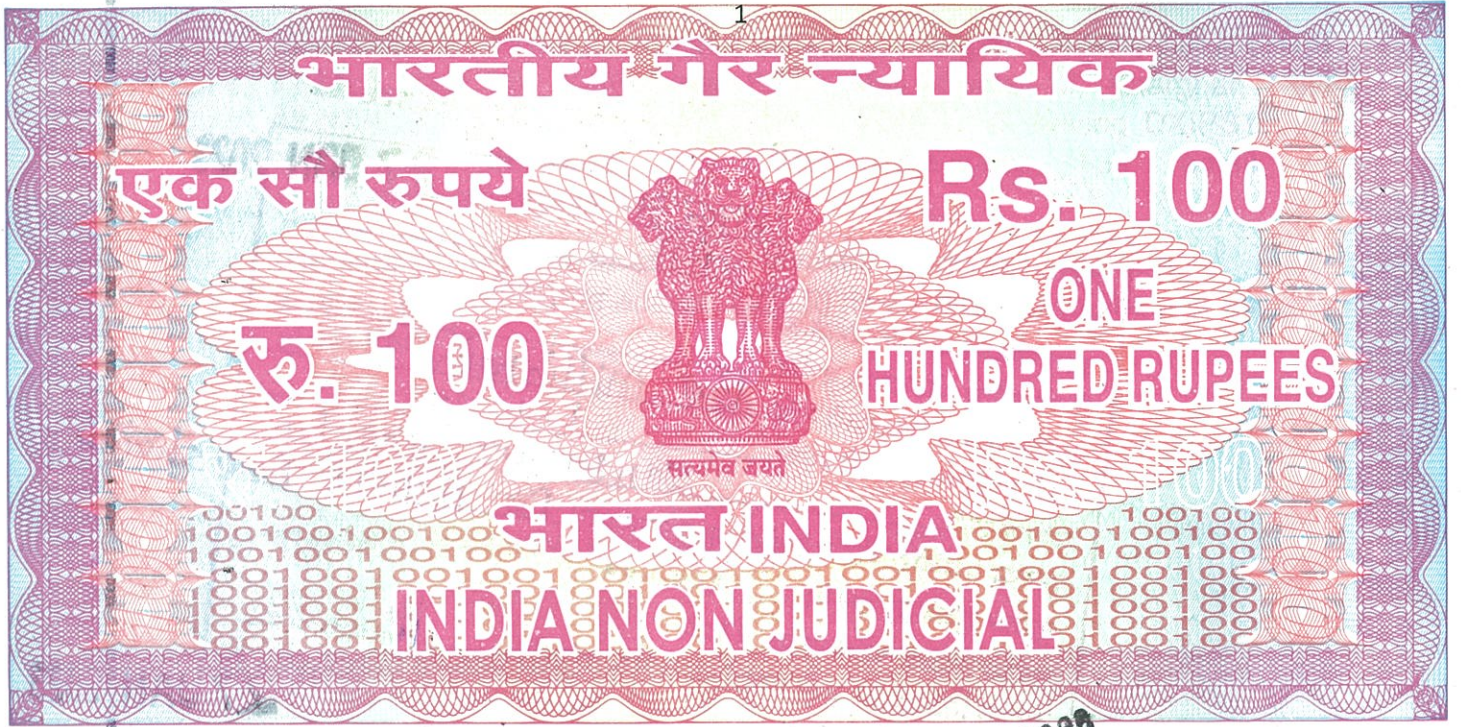

MEMORANDUM OF UNDERSTANDING

1. This MOU is made between:

- a. M/S Be Millionaire, office at 704/B, Makhdoomi Palace, Vakola, Santacruz (E), Mumbai 400055, having PAN AAZFB9324M, copy enclosed with this agreement has email id info@bemillionaire.com.

(Hereinafter referred to as "The Borrower"), which expression shall, where the context so admits, include its successors-in-title and assigns of the Party 1.

d. In case of any tax deducted/applied at source on profit and/or capital amount will be the responsibility of Party 2, there won't be any provision from Party 1.

e. After MOU tenure is completed then its responsibility of Party 2 to return the original agreement and cheque with NOC without which capital will not be paid fully.

5. Return on Investment:

a. Party 1 promises to professionally manage the borrowed amount of Party 2 and undertakes to give returns on the borrowed amount as outlined below:

b. Party 1 shall be obliged to pay return on the borrowed amount at the rate of Up to 20% (Twenty Percent) per year dispersed by 10<sup>th</sup> day of every month for the duration period of the validity 12 months) of this MOU.

c. The agreed return at the "ROI" of up to 20%, shall be paid and dispersed on a monthly basis.

d. No additional amount will be charged in any form / mode from Party 2 apart from the mentioned return. All amounts are exclusive of GST and TDS and any other taxes. Post successful completion of all the tenure all / everything will be closed, and MOU will be terminated legally.

e. Entire borrowed amount received from Party 2 shall be returned to Party 2 at the end of the MOU period and not before.

f. It is accepted and agreed that between the tenure of MOU Party 2 will not demand and ask for any additional payment / commitment from Party 1 except as mentioned in this MOU.

g. After completion of MOU tenure all the current / past / any / all the loans / dues / balance / transactions / liabilities / MOU'S / holdings / locking / bindings (individual and/or company basis) between Party 1 and Party 2 will be invalid, void, terminated, closed and null from both the sides and nobody will have any legal connections and objections further.

h. Once this MOU is closed legally and mutually after completion of tenure or in other agreed ways then Party 2 will handover original MOU to Party 1 and provide NOC in written to receive the fund.

6. Undertakings:

a. Party 1 undertakes to maintain the funds entrusted to it separate from its own assets and free from the claims of its creditors.

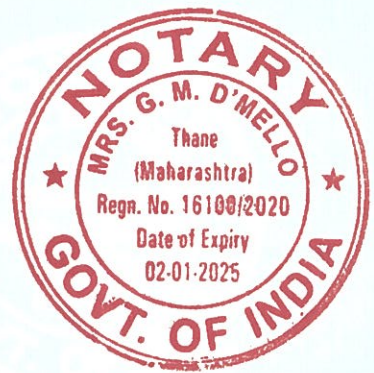

7. Notices:

- a. Any notice pursuant to this MOU shall be given by electronic mail or letter and the onus of confirmation of receipt of such notices shall be on the sender.
- b. Any notice pursuant to this MOU shall be addressed to the parties' addresses given on the first para of these presents.
- c. All the notices/disputes raised or received by either party will be handled only in Mumbai jurisdiction.

8. Dispute Resolution:

- a. In case of any dispute raised by Party 2 apart from any mentioned terms in this MOU then Party 2 will bear all the legal/non legal expenses.
- b. Where any dispute arises among the parties as to the performance or interpretation of this MOU, the parties will resolve the dispute in the following manner:
- c. First, the party raising the dispute must notify immediately the other party of the dispute, providing a reasonable amount of information about the nature of the dispute.
- d. Second, the parties will meet as soon as possible, in person or by video conferencing, and attempt to resolve the dispute by discussion.
- e. Third, if such negotiation fails, then parties will refer the dispute to a mutually acceptable mediator, as soon as possible, to be resolved in accordance with an accepted code of mediation practice, and if they are unable to agree on a mediator then a relevant officer of a mediation centre or a similar body must be requested to select a mediator for the parties.
- f. Fourth, except for urgent injunctions, only after steps (1) to (3) have been followed may a party resort to litigation.

9. Costs:

- a. Party 1 shall be liable for the costs, if any, in respect of the drafting and execution of this MOU and nothing after that i.e., once it's signed by all the parties.

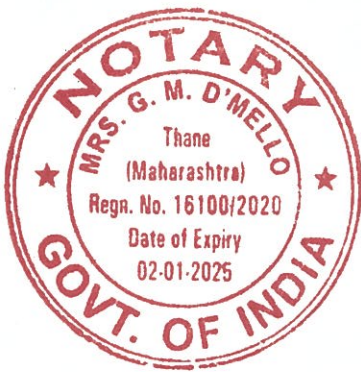
